**June 15<sup>th</sup>: NJ Assembly Insurance Committee held a hearing on PBM abuses and low pharmacy reimbursements**

**November 9<sup>th</sup>: NJ Senate Commerce Committee votes to approve S2301 - MAC Transparency bill**

**January 2016: MAC transparency bill signed into law.**

**The MAC Transparency bill S2301/A3522 will put an end to PBM abuses:**

- ***Transparent standards when setting generic drug prices and reimbursements***
- ***Daily updating of MAC generic drug pricing***
- ***Provides pharmacies with a real appeals process***
